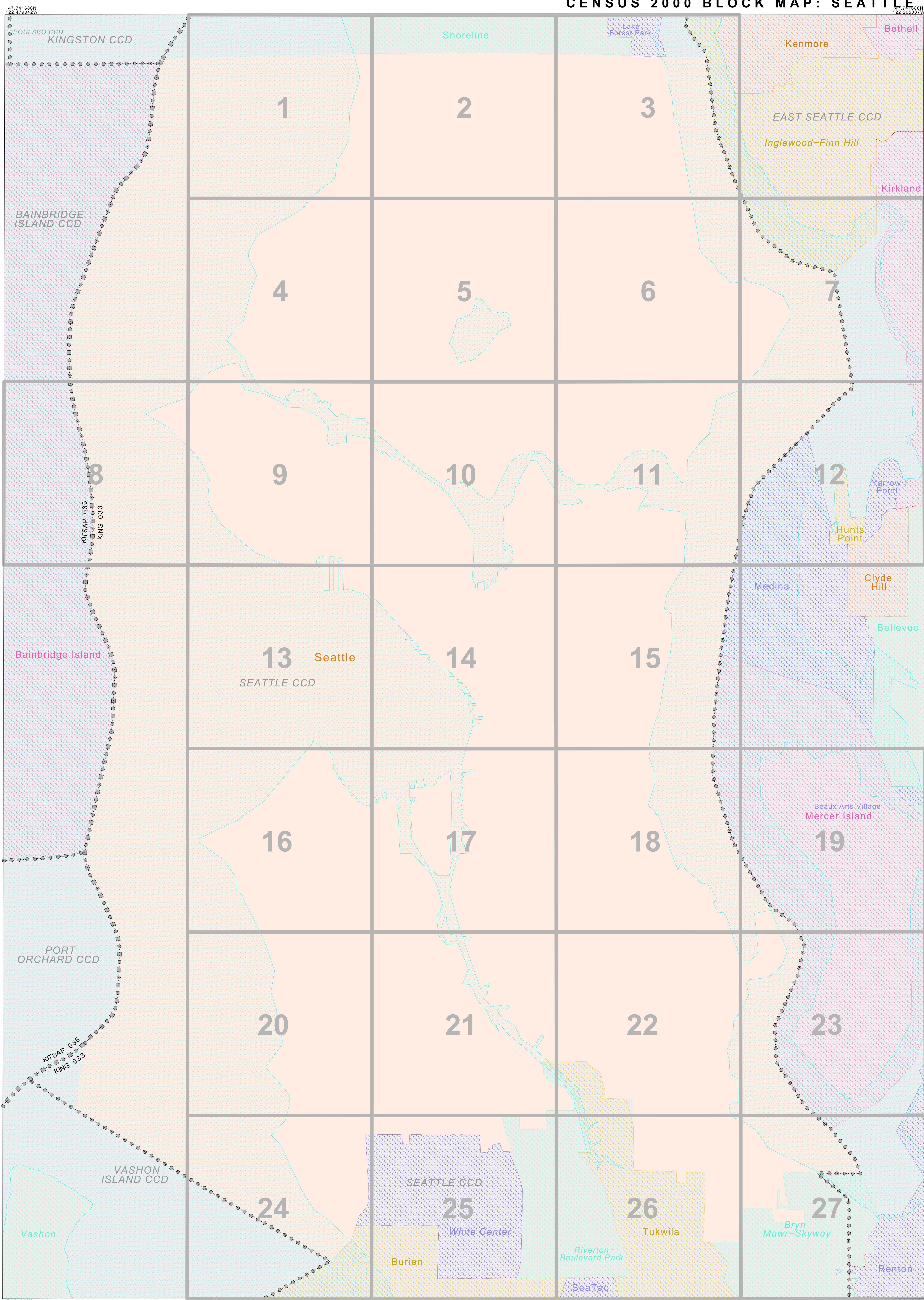


# CENSUS 2000 BLOCK MAP: SEATTLE City



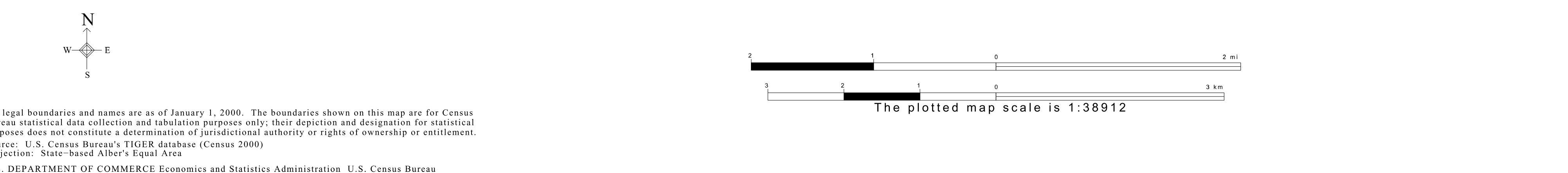
