



2ND AVE MOBILITY IMPROVEMENTS

Signal upgrades and protected bike lane extension

PROTECTED BIKE LANE INSTALLATION

On Monday, October 23, crews plan to start installation of the protected bike lane on 2nd Ave from Denny Way to Blanchard St. For approximately 4 weeks, crews will repave the road in the parking lane, bike lane, and adjacent travel lane on the east side of the street, beginning at Blanchard and moving north to Denny. During work, parking and load zones restrictions will be in place on the east side of 2nd from Denny to Blanchard, and crews will work to restore parking as they progress. After this work is complete, 2nd Ave between Denny and Blanchard will have a new lane configuration (see the existing and future images on back page).

UPCOMING CONSTRUCTION SCHEDULE

Monday, October 23: Crews will grind the road to remove the top layer of asphalt between Denny and Blanchard. This work will take approximately 1 day to complete.

Tuesday, October 24: Crews will prepare the road and install new pavement and the concrete buffer between the protected bike lane and the parking lane. This work will take approximately 4 weeks.

Other work during the week of October 23: Crews also plan to remove curb bulbs and restore portions of the road and sidewalk at Bell St on the east side of 2nd. This work will take approximately 2 weeks. During this time, crews with the 3rd Ave Belltown Paving project will also be working on Bell St. Their work will take approximately 4 weeks. During this time, Bell St between 2nd and 3rd will be closed.

Pavement restoration is weather dependent and may be rescheduled.



WHAT TO EXPECT DURING CONSTRUCTION OF THE PROTECTED BIKE LANE

- No parking on the east side of 2nd Ave between Denny and Blanchard; parking/loading will be replaced as the protected bike lane is installed
- Two lanes of traffic will generally be maintained between Denny and Blanchard
- People biking will merge with traffic
- Noise, dust, and vibration near work zone
- Work hours: 7 AM to 7 PM

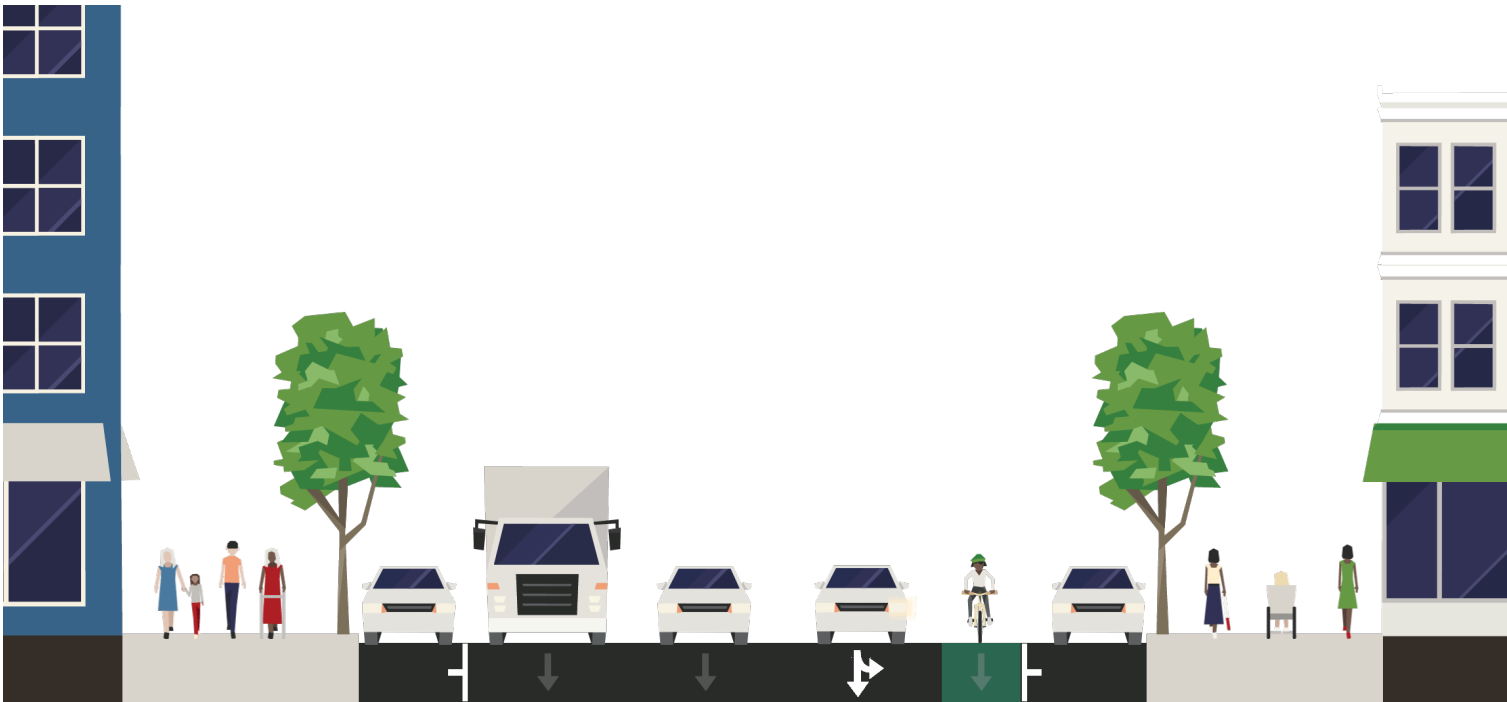

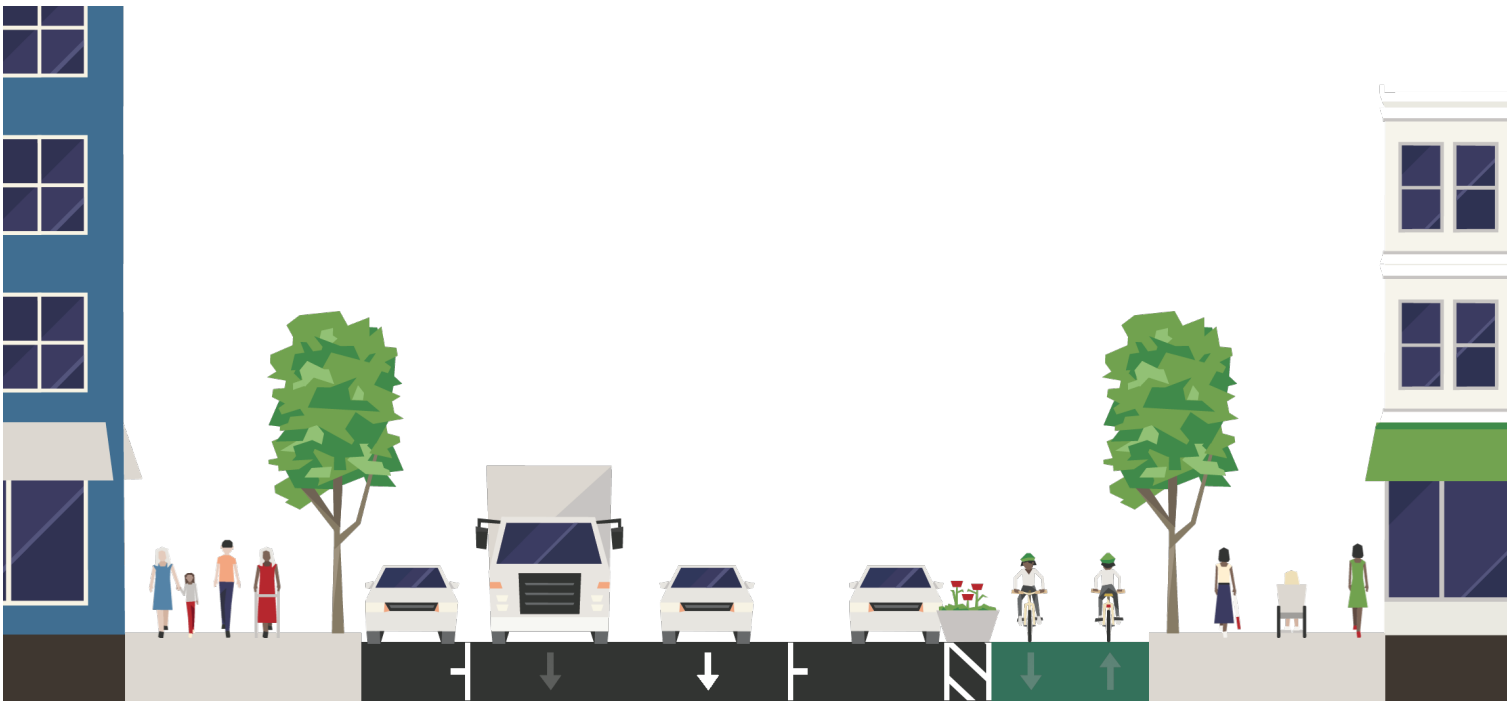


Typical cross section of 2nd Ave (looking north)
